

RESORT VILLAGE OF MANITOU BEACH  
BYLAW #7/2016

Bylaw of the Resort Village of Manitou Beach in the Province of Saskatchewan to fix the rates to be charged for use and consumption of water and to fix the rates to be charged by way of rent or service for the use of sewer services.

The Council of the Resort Village of Manitou Beach, in the Province of Saskatchewan, enacts as follows:

1. The charges to be paid by the water consumer of which municipal water and sewer service has been made available and turned on shall be those set out in Schedule "A" attached; provided, however, that the minimum shall be payable in every case whether or not any water is consumed.
2. Persons who own or occupy premises drained or that are by bylaw required to be drained into the sewer shall pay for such services a rental or service charge in accordance with Schedule "B" attached.
3. New water meters will be supplied on request OR for new construction OR as part of a program to update meters.
4. Accounts for water service and/or sewer service shall cover a period of two (2) successive months, and shall be rendered within seven (7) days after the last day of the month ending such period. Accounts shall be paid within a period of thirty (30) days from the date on which such accounts are rendered.

All water and sewer accounts which are outstanding thirty (30) days after the account is rendered shall have a penalty of:

2% (percent) of the arrears per month added to the account  
OR

The water service will be cut off.

When the water service is so cut off, it shall not be turned on until all arrears have been paid, together with a fee of \$50.00 to cover the expenses of turning off the water and a further fee of \$50.00 for turning it on again. If requested to turn on the water outside the employee's regular working hours the fee is \$120.00.

5. Water and sewer consumers shall pay a per billing Infrastructure Fee in accordance with Schedule "C". The Infrastructure Fee will be used for water and sewer capital acquisitions; capital debt payment or placed in specified reserve funds.
6. Bylaw # 1/2015 is hereby repealed.
7. The rates, tolls or rents contained in this bylaw shall come into force and take effect on the day of approval being issued by the Local Government Committee.

Schedule "A" to Bylaw #7/2016

BI-MONTHLY WATER RATES: (every 2 months)

4,000 gallons or less – minimum charge \$ 96.80  
4,001 gallons and over \$ 13.20 per 1,000 gallons (or part thereof)

QUARTERLY WATER RATES: (every 3 months)

Watrous South Rural Water Utility \$12.20 per 1000 gallons (or part thereof)  
minimum charge for 4000 gallons does not apply to this item  
minimum charge for 275,000 imperial gallons does apply

Minimum water service duration for Seasonal Commercial and Residential users shall be based on a 2 month charge and prorated per day when duration is less than a 2 month period.

Curb stop connection fees, \$35.00 and disconnect fees \$35.00 to be applied at extra cost.  
Seasonal users shall pay a flat rate of \$50.00 for the season on and off to be applied at extra cost on the first billing.

Schedule "B" to Bylaw #7/2016

BI-MONTHLY SEWER SERVICE CHARGES (every 2 months)

Residential Fee: \$25% of the water charge Commercial Fee: 35% of the water charge

Base Rates will be applied according to the following categories:

Residential Base Rate: \$20.00  
Commercial Base Rate: \$30.00  
Year round Commercial  
Salt Water Swim Pool \$1900.00  
Commercial Campground \$800  
Storm Water Base Rate for  
Commercial & residential properties \$10.00

Minimum sewer service duration for Seasonal Commercial and Residential users shall be set at 2 months and run concurrent with water service set up as set forth in Schedule "A" to Bylaw #1/2015.
