4.0 DELEGATIONS

Delegation Raquel Hilbert, candidate for the Watrous-Humboldt Sask Party constituency, introduced herself to Council and gave a brief introduction into her interest in Provincial politics. Council & Administration gave Ms. Hilbert a municipal perspective on issues that affect our resort village such as provincial revenue sharing, grant funding streams missing infrastructure, the role of the Saskatchewan Municipal Board, etc. Ms. Hilbert shared personal experience that may be available to partner with educational institutions and have civil engineering students work on design for municipal infrastructure. Council thanked Ms. Hilbert for her interest in municipal issues.

Ms. Hilbert left the Council meeting at 2:22 pm.

Delegation Barry Morishita, MSMA Director, attended the Council meeting to discuss the Sylvite 4-6 Regional Planning Group. The upcoming housing forum in Humboldt, Sk. Was discussed, as well as the potential Community Response Group. Governance and representation on the regional planning group, Sylvite 4-6 was discussed along with advantages going forward.

Councillor Armstrong declared a conflict regarding the next delegation and removed himself from the council table at 2:39 pm.

Delegation Dave Sikler, Resort Village of Manitou Beach Ratepayer, attended as a delegation to request a discretionary use application for 106, 108, & 110 Watrous Street. Mr. Sikler discussed his plans to restore the presence of health and wellness to the community. Mr. Sikler discussed his plans for a treehouse, glamping domes, and phases of his proposed project. Council requested more information and discussed development standards, and discretionary uses. Council reiterated the importance of trust when discretionary use applications are being made, and how abiding by municipal

direction is important when acting within the community. Mr. Sikler's Zoning Bylaw infraction (setting up a RV on his property despite clear indication by the village office that this was not a permitted use) was discussed, along with the request to remove the camper trailer, that had not been abided by at the time of meeting.

Drainage is an issue and area of concern. WSA was in attendance. New irrigation project also a concern. Councillor Mattick discussed the Delwood Reservoir maintenance work and concern over spillage when re-filling the reservoir after construction is complete. Councillor Mattick discussed the importance of advocacy to both the ministers in charge as well as the deputy ministers.

Councillor Gill discussed the moving of the last chainsaw carving from the compound. Councillor Gill has observed new garbage cans along the connecting trail. Councillor Gill also initiated discussion on the ramp on the shed in the chainsaw compound.

Mayor Petersen discussed the SUMA convention. Mayor Petersen inquired into dates for the collaborative Watrous-Manitou Council's meeting. Administration advised that we are awaiting reply from Watrous as ascertain if proposed dates work for their Council. Mayor Petersen initiated discussion with the Rotary's 85th birthday on the horizon, the event will take place June 21st, supper tickets are \$50.00, and is open to the public.
